
The board received a statement from TD Bank and gave it to Commissioner Corino for him to reconcile the checkbook.

The Board received a monthly statement from TD Bank and gave it to Commissioner Corino for him to reconcile the checkbook.



Commissioner Rockensies and Barnett reported that they responded to a water service leak at Westminster Road and directed the resident to contact a plumber to make the repairs.


