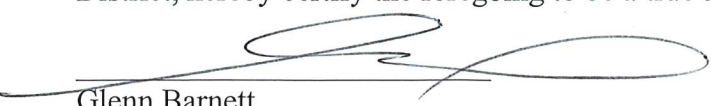

Commissioner Barnett reported that while he was flushing hydrants, he found that several small caps on the hydrants were difficult if not impossible to open, he recommends that all hydrant caps be checked and exercised to ensure they are operable. He did contact Orchid Plumbing to have their crew respond to open the inoperable caps and to place red grease on the threads.

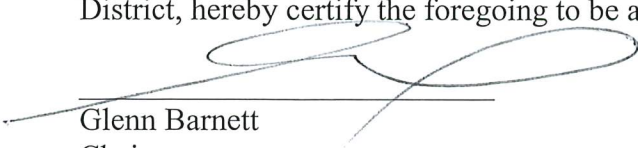
